## EU4Health 2023 work programme

The EU4Health Programme is the main financial instrument to fund the Union health initiatives and it is implemented through annual work programmes. The funding will be provided in the form of grants, procurement and prizes, directly by the Commission or by the Health and Digital Executive Agency (HaDEA).

On  $21^{st}$  November, the European Commission adopted the 2023 EU4Health annual work programme which, with a budget of  $\in$  735,8 million, it will build the way towards a strong European Health Union, supporting crisis preparedness, disease prevention, health systems and the healthcare workforce, and digitalisation.

As highlighted in the programme, NGOs play a major role among others in providing aid at EU, national and local levels. In the field of health, and specially public health, they provide services directly to patients and individuals being in some cases in the first line of action also during emergencies. NGOs are also essential in bridging the gap between institutions and patients and facilitating communication at national and EU level. These organisations are not-for-profit and therefore necessarily rely on funding from different sources, for instance private donations, national or international contributions.

Therefore, the information session is organised by HaDEA to present the procedure for Non-Governmental Organisations (NGOs) operating grants under the EU4Health 2023 Annual Work programme.
